GUIDANCE ON ENROLMENT

Entry Level

At the entry level there are the 'Ordinary Members', 'Associates' and 'Affiliates.'

The eligibility criteria for each of these categories are summarized below:

(i) Ordinary Member

- A Form 20 Director of a Private or Public Sector Company, incorporated in Sri Lanka shall be eligible to join the Institute as an Ordinary Member.

(ii) An Associate of the Institute shall include any one of the following:

- a Partner of a professional practice, recognised by the Institute and registered in Sri Lanka
- a Sole Proprietor or a Partner of an incorporated/unincorporated business, registered in Sri Lanka
- a Senior Manager of a Private or Public Company or Partnership incorporated in Sri Lanka, reporting directly to a Director, Partner or Proprietor
- an Academic at the level of Professor or equivalent

(iii) An Affiliate of the Institute shall include any one of the following:

- A person interested in the affairs of the Institute and holding a managerial position and aspiring to be a Director.
- Full-time students at a recognised university, or equivalent, with no management experience studying for a Postgraduate qualification.
